- (1) Mr. Young was issued Deferred Stock Units by NRG Energy, Inc. under NRG Energy Inc.'s Long Term Incentive Plan on June 1, 2007. Each Deferred Stock Unit was equivalent in value to one share of NRG Energy, Inc.'s Common Stock, par value \$0.01. One June 1, 2007, Mr. Young received from NRG Energy, Inc. one such share of Common Stock in exchange for each Deferred Stock Unit he was issued on that same date. Mr. Young no longer holds any Deferred Stock Units.
- (2) On May 2, 2007, NRG Energy, Inc. announced a 2-for-1 stock split, in the form of a stock dividend paid on May 31, 2007 to all holders of record of Common Stock on May 22, 2007, which resulted in Mr. Young's ownership of 20,615 additional shares of Common Stock. The Company's Common Stock began trading on a split-adjusted basis on June 1, 2007.
