(1) The shares were sold pursuant to a 10b5-1 Sales Plan.

The original Form 4, as amended on November 5, 2007, reflected an exercise of derivative securities in connection with the sale of shares under the Reporting Person's 10b5-1 Plan. The Reporting Person is amending the original Form 4, as amended, for the purpose of reflecting that derivative securities were not exercised, but that the shares were sold from shares held by the Reporting Person.

(3) The Reporting Person's October 24, 2006 Form 4 reflected a sale of 3,392 shares under the Reporting Person's 10b5-1 Plan. The actual number of shares sold were 5,000. The balance of securities beneficially owned by the Reporting Person reflects the 1,608 shares that were sold at \$12.64 per share on October 24, 2006, but not previously reported.
