- (2) indirectly owns 3,483,471 common units of the issuer through three of its wholly-owned subsidiaries (Martin Product Sales LLC, Midstream Fuel Service LLC and Martin Resource LLC). As a result, Ruben S. Martin may be deemed the beneficial owner of the common units and subordinated units owned by Martin Resource Management Corporation.
