The name change resulted from the novation of Portfolio Management Agreements from Nicholas-Applegate Capital Management to Allianz Global Investors Capital LLC ("AGIC") on August 25th, 2010.

The Shares reported herein represent UBS AG's combined holdings in multiple series of auction preferred securities of the issuer.
