- (4) These awards of performance units relate to the 2012, 2013 and 2014 performance periods, respectively, and represent the maximum amount that may vest for each year assuming the Company achieves the respective year's annual stretch goal for RONA. The performance units may vest fewer than the maximum amount, provided that the Company achieves positive operating income.
