- (1) The weighted average sale price reflects multiple transactions at prices ranging from \$53.02 - \$53.18.

The final award of shares issued can be between 0% and 200% of the target award.

- (8) Each restricted stock unit represent a contingent right to receive one share of Company common stock. The restricted stock units vest in four equal annual installments beginning on the exercisable date.
- (9) Balance reflects dividends paid on Restricted Stock Units and reinvested in additional Restricted Stock Units, under the Company's 2010 Omnibus Incentive Plan on March 20, 2012.
