Pursuant to PayPal's Cert. of Incorporation (as amended), effective as of the close of business on the date set by resolution of the Board of Directors of eBay as the record date for distribution of shares of PayPal's Common Stock to holders of shares of eBay's common stock (such time, the "Effective Time"), the 1,000 shares of PayPal's Common Stock held by eBay prior to the Effective Time shall, automatically by operation of law and without any further action of the part of PayPal or eBay, be subdivided and converted into a number of shares of validly issued, fully paid and non-assessable shares of PayPal's Common Stock equal to the number of shares of common stock, par value \$0.001 per share, of eBay, issued and outstanding as of the Effective Time.
