- (2) "Merger"), in exchange for ordinary shares of New STERIS, which was consummated simultaneous with and conditioned on New STERIS' acquisition of Synergy Health plc by commencing a "recommended offer" under English law. At the effective time of the Merger, each STERIS common share was cancelled and converted into the right to receive one New STERIS ordinary share.
- This option becomes exercisable as follows: 2,925 on May 28, 2016; 2,925 on May 28, 2017; 2,925 on May 28, 2018 and 2,925 on May
- (3) 28, 2019. This option was assumed by New STERIS in the Merger and converted to an option to purchase 11,700 ordinary shares of New STERIS for \$65.05 per share, subject to the same terms and conditions that were applicable to the original STERIS option.
