Actual number of shares upon vesting may range from 0% to 200% dependent on the Company's relative shareholder return as compared to its peer group over a three-year period beginning January 1, 2016 and ending December 31, 2018. The Compensation Committee has the option to pay the value in cash at its discretion.
- (3) Amount reported is 200% of the number of PSUs granted and the maximum number that may be earned.
- (4) Upon payment of the PSUs which, shall occur no later than March 15, 2019.
