The actual number of performance stock units that may be earned will be based on the Company's total stockholder return ("TSR") over a three-year performance period, beginning on January 1, 2016 and ending December 31, 2018. The number of performance stock units shown in column 5 is equal to the target number of performance stock units that may be earned.
- (2) Represents the end of the performance period to which the performance stock units relate.
- (3) This option vests in three equal installments on January 1, 2017, 2018 and 2019.
