- (2) The exercise reported was effected pursuant to a Rule 10b5-1 trading plan adopted by Mr. Stroup on August 18, 2016.

This represents the difference between the number of SARs exercised (40,000) and the number of shares issued as a result of the exercise

The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$76.03) and the exercise price (\$50.01). Additional shares are then withheld to satisfy the Company's tax withholding obligations.
