- (6) Each Restricted Stock Unit is the equivalent of one share of Forrester Research, Inc. common stock.
- (7) On August 1, 2016, the reporting person was granted 7056 Restricted Stock Units that vest and convert into common stock in four equal and consecutive installments beginning on the first anniversary of the grant date.
