- (3) Pursuant to the Merger Agreement, this option, which provided for vesting upon the achievement of certain target trading prices of the Company's common stock prior to March 31, 2014, was cancelled without consideration.
- (4) Pursuant to the Merger Agreement, this option, which vested as to 37,500 shares on June 5, 2011 and 18,750 shares on each of June 5, 2012 and July 26, 2012, was cancelled in exchange for a cash payment of \$6.81 per share representing the difference between the exercise price of the option and the \$12.00 per share merger consideration.
