## **RESOLUTIONS OF THE EXTRAORDINARY GENERAL MEETING**

Rio de Janeiro, May 25th, 2015, Petróleo Brasileiro S.A. - Petrobras hereby informs that the Extraordinary General Meeting, held this day, at 03:00 pm, in the main auditorium of the Company's Head office building, at Avenida República do Chile 65 – 1st floor, in the city of Rio de Janeiro (RJ), ruled and approved, by majority, as follows:

I. The Management Report, Financial Statements and Fiscal Council's Report of Fiscal Year of 2014.

The Federal Government, by voting the only item of this Extraordinary General Meeting, majority vote of the conclave, approved the Management Report, the Financial Statements for the year ended December 31, 2014, together with the Fiscal Council and the Independent Auditors' Reports, with the highlights of the Independent Auditors' Report as well as the record of the National Treasury Secretariat to point out possible effects that may result from the disclosure of new information about the "Lava Jato Operation" which modify materially the assumptions and estimates used in the financial statements.

In its opinion, the Federal Government also determined that Petrobras continues to take the necessary legal measures, and brought to any authority or jurisdiction, individually and/or as a joint party along with the Federal Prosecutor, according to the Law No. 8429, of June 2, 1992

(Action of Administrative Improbity), all of them able to recover the losses due to the acts of its former directors and third parties, as part of "Lava Jato Operation".
