As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 3,441,959 shares of the Company's Common Stock as it holds 3,441,959 warrants to purchase the Company's Common Stock. Each warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$7.50 ("Warrant"). Each Warrant will expire on June 18, 2011, or earlier upon redemption.

As of the date of this filing, Millenco LLC, a Delaware limited liability company ("Millenco"), has ceased to be the beneficial owner of any shares of the Company's Common Stock.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.

4.1% of the Company's Common Stock (see Item 4(a) above), which percentage was calculated based on 79,722,147 shares of the Common Stock outstanding as of October 31, 2008, as per the Company's Form 10-Q dated November 4, 2008.
