Upon the vesting of 2,460 phantom common units granted to the reporting person on March 8, 2010, 50% of the common units were deferred pursuant to the reporting person's prior deferral election under a deferred compensation plan. The deferred common units are settled in cash in the deferred compensation plan. The reporting person settled the remaining phantom common units for an equal number of common units and satisfied the withholding tax liability by withholding common units.
