Value attributable to such Rights, if any, is reflected in the market price of the common stock.

- (1) Vesting on 05/05/2011 of restricted stock units under employer plan - data provided by plan administrator on 05/06/2011 Vesting occurs 25% per year over four years.
- (2) Shares withheld to cover required tax withholding on vesting of restricted stock effective as of 05/05/2011 - data provided by plan administrator on 05/06/2011.

- (4) One share of Apache common stock for each restricted stock unit.
