2,142 shares of ARMOUR common stock pursuant to quarterly compensation paid for the reporting person's service on ARMOUR's Board of Directors. Commencing with the end of the first quarter of 2013, the reporting person may elect to receive up to \$16,500 of the reporting person's total quarterly compensation (or \$66,000 on an annual basis), paid in stock. However, the reporting person may elect to receive some or all of the stock compensation as cash. The 2,142 shares of stock represent the reporting person's election of stock compensation for the past quarter.

- (2) Previous Forms 4 misreported Mr. Bell's indirect ownership by including an additional 75,075 shares of common stock and Mr. Bell's direct ownership by excluding an additional 50,000 shares of common stock.
- (3) Represents shares owned indirectly through Barbican Capital Domestic REIT Fund LP's ("Barbican") brokerage account, which were previously held by Blackbeard Capital Domestic REIT Fund, L.P. The reporting person has a pecuniary interest in the shares held therein.
