## **EXPLANATORY NOTE**

### **Deregistration of Unsold Securities**

BIO-key International, Inc. (the “Company”) filed a Registration Statement on Form S-1 (Registration No. 333-203613) (as amended, the “Registration Statement”), which was declared effective by the Securities and Exchange Commission on May 1, 2015. The Registration Statement registered the resale by the selling stockholders named therein of 498,444 shares of common stock issuable upon the exercise of common stock purchase warrants. The Company is filing this Post-Effective Amendment No. 2 to the Registration Statement to deregister all securities that have not been sold pursuant to the Registration Statement as of the date hereof. Accordingly, as of the effective date hereof, the Company hereby terminates the effectiveness of the Registration Statement and deregisters all securities that remain unsold by the selling stockholders thereunder as of such termination date.
