On the date indicated, Danaher Corporation granted the reporting person restricted stock units (RSUs) in the amount indicated. The RSUs vest on the earlier of the first (1) anniversary of the grant date, or the date of (and immediately prior to) the next annual meeting of Danaher's shareholders following the grant date, but the underlying shares are not issued until the earlier of the director's death or the first day of the seventh month following the director's retirement from the Board.

This filing serves to amend the disclosure set forth in Table 1, Column 5 of the Form 4 filed by the reporting person on April 21, 2017, (2) which reflected the reporting person as beneficially owning 84,800 shares but should have reflected beneficial ownership of 93,053 shares.
