(1) Stock issued pursuant to the Company's 2001 Stock Option and Incentive Plan, in lieu of cash, in payment of Director's fee for board meeting attendance: exempt under Rule 16(b)-3(d). A director is entitled to receive \$1000 for each in-person meeting of the board attended. The number of shares issued is based upon the closing price of the Company's common stock on the date of the meeting (2/4/09)

(2) Stock issued under the Company's Stock Option and Incentive Plan pursuant to a Board policy which provides that if a director retires from the Board after having served at least five years as a director, such director is entitled to receive the equivalent of one year's annual retainer (\$12,000) in the form of stock. Mr. Vigdor retired from the Board on February 4, 2009 after 40 years of service. The number of shares issued is based on the closing price of the Company's common stock on 2/4/09.
