The annual meeting of shareholders (the “Meeting”) of Monmouth Real Estate Investment Corporation (the “Company”) was held on May 13, 2014. There were 46,868,838 shares of common stock entitled to vote at the meeting and a total of 39,962,079 shares (85.26%) were represented in person or by proxy at the meeting.
