- (1) On May 14, 2007, 30,000 shares of restricted common stock were granted. They will vest as follows: 10,000 shares on May 14, 2008; 10,000 shares on May 14, 2009; and 10,000 shares on May 14, 2010.  
On May 14, 2007, Mr. Record was granted Stock Appreciation Rights (SARs) with respect to a total of 100,000 shares of common stock.
- (2) The grant price for the SARs is \$19.96 per share of common stock. The SARs will vest at a rate of 25% per year on each of the first four anniversary dates from the date of grant. They will expire on the earlier of (i) sixty days after termination of employment, or (ii) seven years from the date of grant.
