(1) On August 16, 2006 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 1,183 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the first and second anniversary of the date of grant. On August 16, 2008, 591 shares of the originally granted RSAs vested, of which 175 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.

(2) Between May 21, 2008 and August 19, 2008 the Reporting Person acquired the following shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan: (a) 133 shares pursuant to the Dividend Reinvestment feature of the Plan; and (b) 192 shares pursuant to payroll contributions. This information is based on a plan statement dated July 21, 2008.
