- (2) The premium share units were acquired under Navistar's Executive Stock Ownership Program. Each premium share unit represents one share of Navistar common stock.
- (3) The RSUs became or will become payable in cash, unless Navistar elects to settle the RSUs in common stock, in three annual installments as follows: 7,257 shares on 2/1/2017; 3,629 shares on 2/1/2018; and 1,210 on 2/1/2019.
