(e) Compensatory Arrangements of Certain Officers

On October 31, 2018, the Board of Directors (the “Board”) of the Federal Agricultural Mortgage Corporation (“Farmer Mac”), upon the recommendation of the Compensation Committee of the Board, approved a \$226,000 cash bonus for Lowell L. Junkins in recognition of his performance as Farmer Mac’s Acting President and Chief Executive Officer from December 7, 2017 until October 15, 2018. The Compensation Committee reviewed Mr. Junkins’ performance as Farmer Mac’s Acting President and Chief Executive Officer and qualitatively evaluated his achievements toward the strategic objectives of Farmer Mac, with a particular focus on the effectiveness of his leadership during the transition period of executive management and the successes achieved under his leadership in the areas of corporate governance, internal communications, safety and soundness, human capital, and the onboarding of Bradford T. Nordholm as Farmer Mac’s new President and Chief Executive Officer starting on October 15, 2018. During Mr. Junkins’ service as Farmer Mac’s Acting President and Chief Executive Officer, he continued to receive cash director fees for his service as the Chairman of the Board. He continues to serve as Farmer Mac’s Chairman of the Board.
