## **Section 8 Other Events**

### **Item 8.01. Other Events.**

On November 10, 2010, CIT Group Funding Company of Delaware LLC ( CIT Funding ) delivered to Deutsche Bank Trust Company Americas ( Deutsche Bank ), as trustee, a notice of CIT Funding 's intention to redeem on January 4, 2011 all of CIT Funding 's 10.25% Series B Second Lien Notes maturing in 2017. The Series B Notes were issued on December 10, 2009 in connection with CIT Group Inc. and CIT Funding 's reorganization. As provided in the Indenture governing the Series B Notes, the Redemption Price will be 102.0% of the aggregate principal amount redeemed.

The aggregate principal amount of Series B Notes to be redeemed is \$752,222,135, and represents the entire outstanding principal amounts of the 2017 Series B Notes. After this redemption, all of CIT Funding 's Series B Notes will have been redeemed
