The disposition of shares occurred pursuant to an Exchange and Purchase Agreement between the Issuer and Wells Fargo Municipal Capital Strategies, LLC ("Capital Strategies") pursuant to which Capital Strategies exchanged 480 existing Variable Rate MuniFund

(1) Term Preferred Shares of NQP for an equal number of newly issued Variable Rate MuniFund Term Preferred Shares, Series 2019, of NQP, and purchased 390 newly issued Variable Rate MuniFund Term Preferred Shares, Series 2019, of NQP, for a purchase price of \$100,000 per share.

(2) This statement is jointly filed by Wells Fargo & Company and Capital Strategies. Wells Fargo & Company holds an indirect interest in the securities listed in Table I (the "Securities") by virtue of its indirect ownership of its subsidiary Capital Strategies.
