Pursuant to the terms of the Merger Agreement, immediately prior to the effective time of the Partnership Merger, each issued and

- (6) outstanding vested LTIP Unit of the reporting person was converted into an OP Unit pursuant to the limited partnership agreement of DCTOP. At the effective time of the Partnership Merger, each outstanding OP Unit was automatically converted into the right to receive 1.02 common units of limited partnership interest in Prologis, L.P.

Represents OP Units issued by DCTOP. Provided that the OP Units have been outstanding for at least one year, the OP Units are

- (7) redeemable for an equal number of shares of DCT Common Stock, or at the election of DCT, cash equal to the fair market value of such shares. The OP Units did not have expiration dates.

On November 17, 2014, DCT effected a one-for-four reverse stock split of DCT Common Stock (the "Reverse Stock Split") and,

- (8) concurrently with the Reverse Stock Split, DCTOP effected a corresponding one-for-four reverse split of its outstanding units of limited partnership interest (the "Reverse Unit Split"). The number of securities beneficially owned was adjusted by dividing by four to reflect the Reverse Unit Split.

Pursuant to the terms of the Merger Agreement, at the effective time of the Partnership Merger, each OP Unit was automatically

- (9) converted into the right to receive 1.02 common units of limited partnership interest in Prologis, L.P.
