On March 22, 2007, United Bancshares, Inc. issued a release announcing that its Board of Directors authorized an expansion of its common stock repurchase program from 200,000 to 400,000 shares. Under the Company's ongoing repurchase program, which commenced in July 2005 the Company to date has repurchased approximately 199,000 shares. A copy of the release (Exhibit 99.1) is attached.

On March 22, 2007, United Bancshares, Inc. issued the following release:

United Bancshares, Inc. (Nasdaq: UBOH news), a bank holding company headquartered in Columbus Grove, Ohio with consolidated assets of \$550 million, today announced that its Board of Directors authorized an expansion of its common stock repurchase program from 200,000 to 400,000 shares. Under the Company's ongoing repurchase program, which commenced in July 2005 the Company to date has repurchased approximately 199,000 shares.

The stock repurchase plan authorizes the Company to make repurchases from time to time in a program of market purchases or in privately negotiated transactions as the securities laws and market conditions permit. The market purchases will be made through a market maker in the Corporation's stock. The privately negotiated purchases will be considered on a case-by-case basis and will be made at prevailing market prices. Daniel W. Schutt, the Company's President and CEO stated, "We continue to seek opportunities to enhance shareholder value. The expansion of the Company's current repurchase program provides the additional repurchase capacity needed to be prepared for those potential opportunities". At March 22, 2007, the Company had approximately 3,533,000 shares of common stock outstanding.

United Bancshares, Inc. is the holding company of The Union Bank Company, which serves Allen, Putnam, Sandusky, Van Wert and Wood Counties, with office locations in Bowling Green, Columbus Grove, Delphos, Gibsonburg, Kalida, Leipsic, Lima, Ottawa, and Pemberville.
