Corozal Compania Naviera S.A. is the record holder of 4,762,180 shares, representing 5.7% of the Issuer's issued and outstanding common shares. Corozal Compania Naviera S.A. owns 30% of the issued and outstanding shares of Ironwood Trading Corp., which is the record holder of 9,524,360 shares, representing 11.5% of the Issuer's issued and outstanding common shares. Mr. Symeon Palios owns directly 992,437 Shares, representing 1.2% of the Issuer's issued and outstanding Common Shares. Mr. Symeon Palios controls both Corozal Compania Naviera S.A. and Ironwood Trading Corp.
