- (1) 3,750 restricted shares were granted on 3/9/2018 from the 2013 Stock Bonus Plan and vest over four years; vesting commences with 937 shares on 3/9/19; 938 shares on 3/9/20; 937 shares on 3/9/21; and 938 shares on 3/9/22.
- (2) 9,700 restricted shares are held in an account at Computershare, which have upcoming vesting dates.
- (3) 9,497 shares are held in an account at Computershare; an additional 4,114 shares are held in Mr. Bedner's 401K.
- (4) 10,000 stock options were granted on 3/9/18, which vest 1/3 per year; i.e., 3,334 on 3/9/19; 3,333 on 3/9/20; and 3,333 on 3/9/21.
- (5) 86,000 stock options were granted to Mr. Bedner of which 65,667 are currently exercisable.
