Ownership

(a) Amount beneficially owned:

As of the close of business on November 16, 2012, (i) BVF beneficially owned 790,501 shares of Common Stock, (ii) BVF2 beneficially owned 456,746 shares of Common Stock, (iii) BVLLC beneficially owned 9,894,589 shares of Common Stock, and (iv) ILL10 beneficially owned 290,022 shares of Common Stock.

Partners, as the general partner of BVF and BVF2, the manager of BVLLC and the investment adviser of ILL10, may be deemed to beneficially own the 11,431,858 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, BVLLC and ILL10.
