Henry Bros. Electronics, Inc.'s (Henry Bros.) delayed the filing of its Form 10-K for the year ended December 31, 2006 and its Form 10-Q for the quarter ended March 31, 2007 due to unexplained reconciling items in certain clearing accounts. As such, Henry Bros. is unable to file its Form 10-Q for the quarter ended June 30, 2007 until its Form 10-K the year ended December 31, 2006 and its Form 10-Q for the quarter ended March 31, 2007 have been completed and filed. The Company is in the process of finalizing its work to reconcile certain intercompany and clearing accounts that have caused it to delay the filing of its 2006 Form 10-K and Form 10-Q for the periods ending March 31, 2007 and June 30, 2007. On May 18, 2007 the Company submitted a plan to the American Stock Exchange outlining its plan to regain compliance with their listing standards no later than October 18, 2007. The Company has every expectation of achieving this deadline.
