The additional shares of restricted stock will vest as follows: 24 shares in even increments over 2 years beginning January 2, 2017, 15 shares in even increments over 5 years beginning October 14, 2019, 6 shares in even increments over 2 years beginning November 30, 2017, 26 shares in even increments over 3 years beginning January 2, 2017, 64 shares in even increments over 4 years beginning January 2, 2017 and 79 shares in even increments over 5 years beginning January 4, 2017.
