**Item 1.01. Entry into a Material Definitive Agreement.**

On April 19, 2012, Homeowners Choice, Inc. (the Company ) entered into an Underwriting Agreement (the Underwriting Agreement ) with Houlihan Lokey Capital, Inc., as representative of the underwriters (the Underwriter ), pursuant to which the Company agreed to sell 1,600,000 shares (the Underwritten Shares ) of the Company s common stock, no par value per share (the Common Stock ), for \$11.75 per share, less a 6.0% underwriting commission. Under the terms of the Underwriting Agreement, the Company granted the Underwriter an option to purchase up to an additional 240,000 shares (the Additional Shares ) of Common Stock at the public offering price, less a 6.0% underwriting commission, within 45 days from the date of the Underwriting Agreement to cover over-allotments, if any. The offering is being made pursuant to the Company s effective registration statement on Form S-3, as amended (Registration Statement No. 333-180322), and the Prospectus Supplement dated April 19, 2012. The foregoing is a summary of the Underwriting Agreement and is qualified by reference to the full text of the Underwriting Agreement, which is filed as an exhibit hereto.

The Company expects the closing of the sale of the Underwritten Shares to occur on April 25, 2012.
