Rio de Janeiro, June 17, 2002 - Companhia Vale do Rio Doce (CVRD) announces that Paulo Antonio de Souza Junior, an employee of the Company, has received the "Willy Korf Award for Young Excellence".

Paulo Antonio de Souza Junior, who earned a Ph.D. from Johannes Gutenberg Universitat in Mainz, Germany, is a technology analyst at CVRD's Pelletizing Division.
