**Preliminary Terms**

**Issuer:** Citigroup Global Markets Holdings Inc.

**Guarantor:** Citigroup Inc.

**Underlying:** Amazon.com, Inc

**Pricing date:** August 23, 2018

**Valuation dates:** November 23, 2018, February 25, 2019, May 23, 2019 and August 23, 2019 (the “final valuation date”), each subject to postponement if such date is not a scheduled trading day or certain market disruption events occur

**Maturity date:** August 28, 2019

**Contingent coupon:** 2% to 2.25% per quarter (8% to 9% per annum)\*, **only if** the closing value of the underlying on the immediately preceding valuation date is greater than or equal to the coupon barrier value. **You are not assured of receiving any contingent coupon payments on the securities.**

**Contingent coupon payment dates:** The fifth business day after each valuation date, except that the contingent coupon payment date following the final valuation date will be the maturity date.

**Automatic early redemption:** If, on any potential autocall date, the closing value of the underlying is greater than or equal to the initial underlying value, the securities will be automatically redeemed on the immediately following contingent coupon payment date for an amount equal to the stated principal amount *plus* the related contingent coupon payment.

**Potential autocall dates:** Each valuation date beginning in November 2018 and ending in May 2019

**Coupon barrier:** 77% of its initial underlying value

**Final barrier value:** 77% of its initial underlying value

**Payment at maturity (if the securities are not earlier automatically redeemed):** For each \$1,000 stated principal amount security you hold at maturity:

If the final underlying value is **greater than or equal to** the final barrier value: \$1,000 *plus* the contingent coupon payment due at maturity

If the final underlying value is **less than** the final barrier value: a fixed number of underlying shares of the underlying equal to the equity ratio (or, if we elect, the cash value of those shares based on the final underlying value)

**If the securities are not automatically redeemed prior to maturity and the final underlying value is less than the final barrier value, you will receive underlying**

**shares (or, in our sole discretion, cash) expected to be worth significantly less than the stated principal amount of your securities, and possibly nothing, at maturity, and you will not receive any contingent coupon payment at maturity.**

Initial underlying value: The closing value of the underlying on the pricing date

Final underlying value: The closing value of the underlying on the final valuation date

### **Selected Risk Considerations**

- You may lose a significant portion or all of your investment.
