**Payment of premium on CVRD's Shareholder Debentures**

Rio de Janeiro, September 25, 2006 – Companhia Vale do Rio Doce (CVRD) informs that it will pay a premium on its shareholder debentures of R\$0.021564359 per debenture, amounting to a total of R\$8,379,026.91. This payment is subject to withholding income taxes, with the exception of those institutional investors who have proved exemption from income tax.

The funds will be available from October 2, 2006 at CETIP – Central de Custódia e de Liquidação Financeira de Títulos (Center for the Custody and Financial Settlement of Securities) for those investors holding debentures registered on the SND – Sistema Nacional de Debêntures (National Debenture System), and at Banco Bradesco S.A. for those whose debentures are not linked to the SND.
