Accordingly, on March 13, 2007, the date the stock dividend was paid, the option became exercisable for 157,500 shares at an exercise price of \$14.23 per share.

- (3) This option was previously reported as an option for 98,707 shares of common stock at an exercise price of \$32.62 per share but was adjusted to reflect WCI's 3-for-2 stock splits in the form of 50% stock dividends effective June 24, 2004 and March 13, 2007.
