(1) Grant of restricted stock units. The restricted stock units vest in three equal installments: March 1, 2013; March 1, 2014; and March 1, 2015.

(2) Includes an aggregate of 1,535 supplemental shares that Mr. Forsyth received in connection with the Joint Chapter 11 Plan of Chemtura Corporation, et al., dated August 4, 2010, as amended, which was confirmed by the U.S. Bankruptcy Court for the Southern District of New York on November 3, 2010.

(3) Grant of stock options. The stock options vest in three equal installments: March 1, 2013; March 1, 2014; and March 1, 2015.

(4) Each performance share represents a contingent right to receive one share of Chemtura Corporation common stock. The performance shares vest based on Chemtura Corporation's total shareholder return against the companies comprising the Russell 3000 Index.
