MINUTES OF THE 278th MEETING OF THE BOARD OF DIRECTORS OF

TELEFÔNICA BRASIL S.A.

1. DATE, TIME AND PLACE: August 20th, 2015, at 11 a.m., at Telefônica Brasil S.A. (“Company”) headquarters, located at Av. Eng. Luiz Carlos Berrini, 1376, Cidade Monções, capital of the State of São Paulo.

2. PRESIDING BOARD: Antonio Carlos Valente da Silva, Chairman of the Board of Directors and Breno Rodrigo Pacheco de Oliveira, Secretary of the Board of Directors.

3. ATTENDANCE: The meeting was attended by the Directors that sign this minute, according to the article 19, paragraph 4 of the Bylaws, representing a quorum required for installation and deliberation.

4. RESOLUTIONS:

4.1. DISTRIBUTION OF INTEREST ON OWN CAPITAL OF THE COMPANY: The Board of Directors approved, by unanimous decision, the proposal of distribution of Interest on Own Capital to the Company’s shareholders, in the amount of R\$237,000,000.00 (two hundred and thirty-seven million reais), corresponding to a value of R\$0.131620744028 per common share and R\$0.144782818431 per preferred share, corresponding to a net value, after deducting the Withholding Income tax, of R\$201,450,000.00 (two hundred and one million, four hundred and fifty thousand reais), corresponding to a net value of R\$0.111877632423 per common share and R\$0.123065395666 per preferred share, based on the net profit accounted in the balance sheet of July 31st, 2015, which are imputed to the minimum mandatory dividend of the fiscal year 2015 *ad referendum* of the General Shareholders Meeting. The payment of such

Interest on Own Capital will be carried out before the end of 2016 in a date to be defined by the Company's Board. The Interest on Own Capital shall be credited to shareholders, in accordance to the shareholder registry book position by the end of the day, on August 31st, 2015, including. After this date, Company's share will be considered "ex-Interest on Own Capital".

Since there was no other business to be transacted, the meeting was closed and these minutes were drawn-up by the Secretary of the Board of Directors, which were approved and signed by the Directors present to the meeting, being following transcribed in the proper book.
