- (1) Mr. DeNaples is a participant in FNCF Bancorp, Inc.'s Dividend Reinvestment and Stock Purchase Plan ("DRP"). These transactions are the result of his participation in the DRP in 2017.  
This amount includes 7,799.081 shares acquired by Mr. DeNaples individually through the DRP; and 22.903 shares acquired jointly with his spouse through the DRP. Therefore, Mr. DeNaples holds 1,708,234.4790 shares individually and 5,016.5530 shares jointly with his spouse.
