- (1) Mr. DeNaples is a participant in FNCB Bancorp, Inc.'s Dividend Reinvestment and Stock Purchase Plan ("DRP"). These transactions are the result of his participation in the DRP during December 2017.  
This amount includes 9,338.304 shares acquired by Mr. DeNaples individually through the DRP; and 27.423 shares acquired jointly with his spouse through the DRP. Therefore, Mr. DeNaples holds 1,731,018.020 shares individually and 5,083.390 shares jointly with his spouse.
- (3) Mr. DeNaples spouse is a participant in FNCB Bancorp, Inc.'s Dividend Reinvestment and Stock Purchase Plan ("DRP"). These transactions are the result of her participation in the DRP during December 2017.
- (4) This amount includes 77.946 shares acquired individually by Mr. DeNaples' spouse through the DRP during December 2017. Therefore Mr. DeNaples' spouse holds 15,289.044 shares individually.
