- (1) Each performance-based restricted stock unit represents a contingent right to receive one share of Electronic Arts Inc. common stock.

 Performance-based restricted stock units will vest subject to the terms and conditions of the grant agreement evidencing the award and the Company's 2000 Equity Incentive Plan. The performance conditions are described in the Form of 2018 Performance-Based Restricted Stock Unit Agreement filed as Exhibit 10.3 to the Company's Form 8-K filed with the SEC on May 18, 2018.

- (4) Restricted Stock Units shall vest as to one-third on May 18, 2019, with the remainder of the award vesting in equal installments (one-sixth) on November 18, 2019, May 18, 2020, November 18, 2020 and May 18, 2021.
