(1) These Limited Partnership Units ("Units") were directly purchased by AIMCO Properperites, L.P. ("AIMCO Properties").

This Amendment serves to correct the number of units purchased pursuant to the transaction date of 8/2/2005 by AIMCO Properties and the Amount of Securities Beneficially Owned Following the Reported Transaction. This total consists of 31,558 Units held by AIMCO Properties; 17,341.50 Units held by AIMCO IPLP, L.P. ("IPLP"); 5,459 Units held by IPLP Acquisitions I, L.L.C. ("IPLP Acq"); and 45 Units held by Market Ventures, L.L.C. ("Market"). This error of the total amount was also reflected in subsequent Forms 4 filed between 8/2/2005 and 2/24/2006.

AIMCO-GP is the sole general partner of AIMCO Properties and a wholly-owned subsidiary of AIMCO. IPLP is a joint filer with AIMCO/IPT, Inc. ("AIMCO/IPT") and AIMCO for purposes of Section 13(d) reporting of the Exchange Act. AIMCO/IPT is the sole general partner of IPLP and a wholly-owned subsidiary of AIMCO. IPLP Acq is a joint filer with AIMCO, AIMCO-GP and AIMCO Properties for purposes of Section 13(d) reporting of the Exchange Act. IPLP Acq is a wholly-owned subsidiary of AIMCO Properties, whose general partner is AIMCO-GP, which is a wholly-owned subsidiary of AIMCO. Market is a wholly-owned subsidiary of AG Properties, L.L.C., which is a wholly-owned subsidiary of AIMCO.
